Academic Policy 1.01 – GENERAL REQUIREMENTS: To be eligible for conferral of the Juris Doctor degree, a student must complete the following requirements: 1. Timely filing with the law school Registrar of a formal application to graduate. To be timely, an application must be filed before enrollment for the last trimester of work prior to the graduation date.

If you plan to graduate in Spring 2020, this form must be completed and submitted to the Registrar's Office no later than Tuesday, November 12, 2019. The official graduation date for students completing their requirements at the end of the Spring 2020 term is June 1, 2020.
