The Lawyers Club Janeen Kerper Scholarship is administered by California Western School of Law and the applications are evaluated by Lawyers Club of San Diego. Lawyers Club is a nonprofit specialty bar association seeking to advance the status of women in the law, support and improve the administration of justice, and promote equality of the sexes in our society.

This scholarship has been established to provide financial support to a student who is enrolled at California Western School of Law and meets the following criteria:

- Supports the mission of Lawyer's Club of San Diego to promote equality and the advancement of women in the law (<https://www.lawyersclubsandiego.com/>)
- Has completed 30 units
- Is in the top 50% of their law school class

The scholarship can only be used for tuition and is limited to an annual \$2,000.00 award. Students with CWSL scholarships totaling 100% of tuition are ineligible. The scholarship will be presented at the Lawyers Club Fund for Justice event on Thursday, November 20, 2025, at 12:00-1:30 pm at The Westin San Diego Gaslamp Quarter.
