

Requirements:

Area of Concentration in Business Law

Introduction

To graduate with an Area of Concentration in Business Law, candidates must complete both Core Courses and four or more Electives, with a grade of at least B in each course. Candidates who maintain a cumulative grade point average of B+ or higher in their area of concentration courses will receive an Honors designation.

The Business Area of Concentration includes four requirements:

1. Course requirement
2. Rigorous Writing requirement
3. Practical requirement
4. Student/Professional Organization requirement

All decisions with respect to satisfaction of the requirements for the Area of Concentration shall be made by one of the AOC Directors: Professors Padilla, or Williams.

Course requirements

A total of two core courses and four more electives are required. Candidates must earn a minimum grade of B or higher in *each* of the six courses.. Please select all courses you intend to take. Please note: Not all courses are scheduled every year.

Rigorous Writing requirement

Candidates must complete a rigorous writing requirement, which may consist of any of the following:

1. A scholarly writing paper on a business law topic. A scholarly writing paper shall be at least 20 pages in length (exclusive of footnotes) and be completed under the supervision of a faculty member or Law Review editor; or
2. Transactional documents completed as part of an internship, pro bono project, EXP course, or work with a lawyer or law firm. The transactional documents must be at least 20 pages in length and prepared under the supervision of a faculty member or attorney.
3. A writing project completed as part of a course requirement at the SDSU College of Business as part of the JD/MBA Dual Degree Program. The writing project must be at least 20 pages in length and prepared under the supervision of an SDSU faculty member, attorney or business entrepreneur.

Practical requirement

Candidates must participate in one of the following practical requirements:

1. Undertake an internship of three or more credits in a business law setting, or
2. Participate in business law-related work (paid or pro bono) for a minimum of 100 hours, or
3. Take two experiential course electives ("EXP") which may also count toward the course requirements.

Student/Professional Organization requirement

Candidates must actively participate in one of the following student or professional organizations after completing their second semester for at least one semester.

Or any other relevant organization, with the approval of a Business AOC Director.
