

Requirements:
Area of Concentration in International Law

In today's global economy, lawyers increasingly encounter transnational issues in their practice. The ability to address this global environment requires a solid understanding of international law and an appreciation of political, cultural, and linguistic differences. Students considering a career that may involve clients engaged in cross-border projects or transnational issues should consider this Area of Concentration.

Candidates are required to discuss their application with one of the Co-Directors of the Area of Concentration in International Law. Professors Jamie Cooper and William Aceves serve as the Co-Directors. Other faculty who specialize in international or comparative law include Emily Behzadi, Susan Bisom-Rapp, Pooja Dadhania, and Richard Oppong.

For a student to be eligible for the Area of Concentration, the Application Form must be approved by one of the Co-Directors before the student registers for their fourth trimester in law school.

Candidates must satisfy four requirements in order to successfully complete the Area of Concentration:

1. completion of four courses
2. scholarly writing paper
3. practicum
4. membership in an approved student/professional organization

Upon completion of all four requirements, a candidate must notify one of the Co-Directors.

Candidates who complete the Area of Concentration will receive a designation on their official transcript. Candidates who achieve a *combined average* in Area of Concentration courses of B+ or higher will receive an Honors Designation on their official transcript.

All decisions with respect to satisfaction of the requirements for the Area of Concentration shall be made by the Co-Directors.
